There are no additional incentives available to the Member at this time

1. AEC will offer for sale, Marathon Water Heaters through its Member services Department. These units will afford members greater energy efficiency and comfort. The program will feature 50 gallon units in stock, with other sizes available by order (must pay in advance and available within 10 days). Residential & Commercial Members may purchase these units during regular business hours. Applicable sales tax will apply.
2. Units will be sold only to AEC Members and must be installed on AEC's distribution system. Valid account number or other proper identification must be presented or confirmed. Program will be tracked by the property location(s) and is available to property owners as well as renters. This program is open to new construction as well as retrofits.
3. **All parts** will be warranted by Marathon. A record of property location of installation, rating label, serial number and other required information will be kept by the Cooperative, as well as the member. The Cooperative will stock common replacement parts and will offer service assistance, as needed, to our members. Information about warranty concerns as well as replacement parts will be available during normal business hours for AEC (7:30 am– 5:00 pm / Monday – Friday, excluding holidays).
4. Installation costs for all water heaters sold become the responsibility of the purchaser. AEC will not install or provide service related work for water heater units. The Cooperative will have available (upon request) a listing of recommended plumbers who have met the satisfactory requirements for installation of a Marathon Water Heater.
5. Financing is available (with good pay history and approved credit) at 6% interest for up to 24 months – on bill financing. All financing jobs require licensed plumber installation.
